A BILL TO BE ENTITLED

AN ACT

1  
2 relating to emergency response employees or volunteers and others  
3 exposed or potentially exposed to certain diseases or parasites.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Article 18.22(a), Code of Criminal Procedure, is  
6 amended to read as follows:

7 (a) A person who is arrested for a misdemeanor or felony and  
8 who during the commission of that offense or an arrest following the  
9 commission of that offense causes an emergency response employee or  
10 volunteer, as defined by Section 81.003, Health and Safety Code, [a  
11 peace officer] to come into contact with the person's bodily fluids  
12 shall, at the direction of the court having jurisdiction over the  
13 arrested person, undergo a medical procedure or test designed to  
14 show or help show whether the person has a communicable disease.  
15 The court may direct the person to undergo the procedure or test on  
16 its own motion or on the request of the emergency response employee  
17 or volunteer [peace officer]. If the person refuses to submit  
18 voluntarily to the procedure or test, the court shall require the  
19 person to submit to the procedure or test. Notwithstanding any  
20 other law, the person performing the procedure or test shall make  
21 the test results available to the local health authority and the  
22 designated infection control officer of the entity that employs or  
23 uses the services of the affected emergency response employee or  
24 volunteer, and the local health authority or the designated

1 infection control officer of the affected employee or volunteer  
2 shall notify the emergency response employee or volunteer [~~peace~~  
3 ~~officer~~] of the test result. The state may not use the fact that a  
4 medical procedure or test was performed on a person under this  
5 article, or use the results of the procedure or test, in any  
6 criminal proceeding arising out of the alleged offense.

7 SECTION 2. Section 607.102, Government Code, is amended to  
8 read as follows:

9 Sec. 607.102. NOTIFICATION. An [~~A firefighter or~~]  
10 emergency response employee or volunteer, as defined by Section  
11 81.003, Health and Safety Code, [~~medical technician~~] who is exposed  
12 to methicillin-resistant Staphylococcus aureus or a disease caused  
13 by a select agent or toxin identified or listed under 42 C.F.R.  
14 Section 73.3 is entitled to receive notification of the exposure in  
15 the manner prescribed by Section 81.048, Health and Safety Code.

16 SECTION 3. Section 12.0127, Health and Safety Code, is  
17 amended by adding Subsection (c) to read as follows:

18 (c) To the extent allowed by federal law, the department  
19 shall provide an equal opportunity to request a waiver of the  
20 foreign country residence requirement for an individual described  
21 by Subsection (a) who agrees to practice medicine in:

22 (1) an area that the department determines is affected  
23 by an ongoing exposure to a disease that is designated as reportable  
24 under Section 81.048;

25 (2) a medically underserved area; or

26 (3) a health professional shortage area.

27 SECTION 4. Section 81.003, Health and Safety Code, is

1 amended by adding Subdivisions (1-a) and (1-b) and amending  
2 Subdivision (8) to read as follows:

3 (1-a) "Emergency response employee or volunteer"  
4 means an individual acting in the course and scope of employment or  
5 service as a volunteer as emergency medical service personnel, a  
6 peace officer, a detention officer, a county jailer, or a fire  
7 fighter.

8 (1-b) "Designated infection control officer" means  
9 the person serving as an entity's designated infection control  
10 officer under Section 81.012.

11 (8) "Reportable disease" means a [~~includes only a~~]  
12 disease or condition included in the list of reportable diseases  
13 and includes a disease that is designated as reportable under  
14 Section 81.048.

15 SECTION 5. Subchapter A, Chapter 81, Health and Safety  
16 Code, is amended by adding Sections 81.012 and 81.013 to read as  
17 follows:

18 Sec. 81.012. DESIGNATED INFECTION CONTROL OFFICER. (a) An  
19 entity that employs or uses the services of an emergency response  
20 employee or volunteer shall nominate a designated infection control  
21 officer and an alternate designated infection control officer to:

22 (1) receive notification of a potential exposure to a  
23 reportable disease from a health care facility;

24 (2) notify the appropriate health care providers of a  
25 potential exposure to a reportable disease;

26 (3) act as a liaison between the entity's emergency  
27 response employees or volunteers who may have been exposed to a

1 reportable disease during the course and scope of employment or  
2 service as a volunteer and the destination hospital of the patient  
3 who was the source of the potential exposure;

4 (4) investigate and evaluate an exposure incident,  
5 using current evidence-based information on the possible risks of  
6 communicable disease presented by the exposure incident; and

7 (5) monitor all follow-up treatment provided to the  
8 affected emergency response employee or volunteer, in accordance  
9 with applicable federal, state, and local law.

10 (b) The executive commissioner by rule shall prescribe the  
11 qualifications required for a person to be eligible to be  
12 designated as an infection control officer under this section. The  
13 qualifications must include a requirement that the person be  
14 trained as a health care provider or have training in the control of  
15 infectious and communicable diseases.

16 (c) The entity that employs or uses the services of an  
17 emergency response employee or volunteer is responsible for  
18 notifying the local health authorities or local health care  
19 facilities, according to any local rules or procedures, that the  
20 entity has a designated infection control officer or alternate  
21 designated infection control officer.

22 Sec. 81.013. CONSIDERATION OF FEDERAL LAW AND REGULATIONS.  
23 The executive commissioner shall review the Ryan White HIV/AIDS  
24 Treatment Extension Act of 2009 (Pub. L. No. 111-87) or any  
25 successor law and any regulations adopted under the law and  
26 determine whether adopting by rule any part of the federal law or  
27 regulations is in the best interest of the state to further achieve

1 the purposes of this chapter. If the executive commissioner  
2 determines that adopting the federal law or regulations is in the  
3 best interest of the state to further achieve the purposes of this  
4 chapter, the executive commissioner may by rule adopt all or a part  
5 of the federal law or regulations.

6 SECTION 6. Section 81.046(c), Health and Safety Code, is

8 (c) Medical or epidemiological information may be released:

9 (1) for statistical purposes if released in a manner  
10 that prevents the identification of any person;

11 (2) with the consent of each person identified in the

13 (3) to medical personnel treating the individual,  
14 appropriate state agencies in this state or another state, a health  
15 authority or local health department in this state or another  
16 state, or federal, county, or district courts to comply with this  
17 chapter and related rules relating to the control and treatment of  
18 communicable diseases and health conditions or under another state  
19 or federal law that expressly authorizes the disclosure of this  
20 information;

21 (4) to appropriate federal agencies, such as the  
22 Centers for Disease Control and Prevention of the United States  
23 Public Health Service, but the information must be limited to the  
24 name, address, sex, race, and occupation of the patient, the date of  
25 disease onset, the probable source of infection, and other  
26 requested information relating to the case or suspected case of a  
27 communicable disease or health condition; [~~or~~]

1           (5) to medical personnel to the extent necessary in a  
2 medical emergency to protect the health or life of the person  
3 identified in the information; or

4           (6) to a designated infection control officer.

5           SECTION 7. The heading to Section 81.048, Health and Safety

24 the person demonstrates that the person was exposed to the  
25 reportable disease while providing emergency care. The executive

13 (b) This subsection applies only in a case of accidental  
14 exposure of certified emergency medical services personnel, an  
15 emergency response employee or volunteer ~~[a firefighter, a peace~~  
16 ~~officer]~~, or a first responder who renders assistance at the scene  
17 of an emergency or during transport to the hospital to blood or  
18 other body fluids of a patient who is transported to a licensed  
19 hospital. The hospital receiving the patient, following a report  
20 of the exposure incident, shall take reasonable steps to test the  
21 patient for hepatitis B, ~~[or]~~ hepatitis C, HIV, or any reportable  
22 disease if the report shows there is significant risk to the person  
23 exposed. The organization that employs the person or for which the  
24 person works as a volunteer in connection with rendering the  
25 assistance is responsible for paying the costs of the test. The  
26 hospital shall provide the test results to the department or to the  
27 local health authority and to the designated infection control

1 officer of the entity employing or using the services of an affected  
2 emergency response employee or volunteer, which are responsible for  
3 following the procedures prescribed by Section 81.050(h) to inform  
4 the person exposed and, if applicable, the patient regarding the  
5 test results. The hospital shall follow applicable reporting  
6 requirements prescribed by Subchapter C. This subsection does not  
7 impose a duty on a hospital to provide any further testing,  
8 treatment, or services or to perform further procedures.

9 SECTION 11. Section 81.0955(a), Health and Safety Code, and  
10 Section 81.0955(b), Health and Safety Code, as amended by S.B. 219,  
11 Acts of the 84th Legislature, Regular Session, 2015, are amended to  
12 read as follows:

13 (a) This section applies only to the accidental exposure to  
14 the blood or other body fluids of a person who dies at the scene of  
15 an emergency or during transport to the hospital involving an  
16 emergency response employee or volunteer [~~certified emergency~~  
17 ~~medical services personnel, a firefighter, a peace officer,~~] or  
18 another [a] first responder who renders assistance at the scene of  
19 an emergency or during transport of a person to the hospital.

20 (b) A hospital, certified emergency medical services  
21 personnel, a justice of the peace, a medical examiner, or a  
22 physician on behalf of the person exposed, following a report of the  
23 exposure incident, shall take reasonable steps to have [~~test~~] the  
24 deceased person tested for reportable [~~communicable~~] diseases. The

26 of the peace, medical examiner, or physician shall provide the test  
27 results to the department or to the local health authority and to

<b>No significant fiscal implication to the State is anticipated.</b>
---

The bill would amend the Code of Criminal Procedures, the Government Code, and the Health and Safety Code relating to emergency response personnel's exposure or potential exposure to certain diseases or parasites, including post-exposure testing and related notifications of results. The bill would require that entities that employ or use the services of an emergency response employee or volunteer designate an infection control officer and alternate officer; qualifications and duties are specified in the bill.

The Office of Court Administration, the Texas Medical Board, and the Department of State Health Services indicate that implementation of the bill could be absorbed within current resources. The Health and Human Services Commission indicates a minimal cost related to enterprise support, but it is assumed that this cost can be absorbed within current resources.

**Local Government Impact**

The bill would require an entity that uses emergency response employees or volunteers to designate an infection control officer to comply with certain administrative and investigative duties. There may be an administrative cost to local governmental entities to comply with the provisions of the bill; however, the fiscal impact would vary depending on the resources of the department.

**Certification of Compliance with  
Rule 13, Section 6(b), House Rules of Procedure**

Rule 13, Section 6(b), House Rules of Procedure, requires a copy of a conference committee report signed by a majority of each committee of the conference to be furnished to each member of the committee in person or, if unable to deliver in person, by placing a copy in the member's newspaper mailbox at least one hour before the report is furnished to each member of the house under Rule 13, Section 10(a). The paper copies of the report submitted to the chief clerk under Rule 13, Section 10(b), must contain a certificate that the requirement of Rule 13, Section 6(b), has been satisfied, and that certificate must be attached to the copy of the report furnished to each member under Rule 13, Section 10(d). Failure to comply with this requirement is not a sustainable point of order under Rule 13.
