(a-1) A landowner to whom a notice is mailed by the county clerk may exclude the landowner's property from the application of this Act by notifying the Texas Department of Transportation in writing, by certified mail. In order for the landowner's property to be excluded from the application of this Section, the landowner's notice must be received by the Texas Department of Transportation within one year of the date the Texas Department of Transportation receives notification from all appropriate county clerks that notices were mailed to landowners as provided by this Section. The exclusion of the landowner from the application of this Section becomes effective on the date the landowner's notice is received by the Texas Department of Transportation.

(2) On page 3, line 24, strike "SECTION 2" and substitute "SECTION 3".

SECTION 2. Section 391.252, Transportation Code, is amended by adding Subsections (a-1) and (a-2) to read as follows:

(a-1) If a billboard is located on premises described by Subsection (a), the billboard may not be removed from the premises without the permission of the owner of those premises.

(a-2) If a billboard is removed in violation of Subsection (a-1) the billboard may be reconstructed or a new billboard erected on the premises.

(2) On page 3, line 24, strike "SECTION 2" and substitute "SECTION 3".

### **CSHB 410 - STATEMENT BY REPRESENTATIVE GATTIS**

I offered an amendment to this bill banning all billboards in the unincorporated areas of Williamson County to send a message to the billboard industry that a few of their member's business practices and blatant disregard for the laws of the State of Texas are outrageous. The industry needs to police and take care of their own. Most are good actors; however, there are some who jeopardize the business of all the others. Furthermore, I must point out that those whose property rights who are not ever discussed or considered in this debate are those whose property lies adjacent to large billboards. Not only is their property devalued, but their quality of life is affected as well. It is a well understood and often stated maxim that one person's rights extend only so far as their neighbor's nose.

### **CSHB 733 ON SECOND READING**

**(by Krusee)**

**CSHB 733**, A bill to be entitled An Act relating to the sale of certain used trucks; providing penalties.

#### **Amendment No. 1**

Representative Driver offered the following amendment to **CSHB 733**:

Amend **CSHB 733** as follows:

(1) On page 1, line 8, strike the comma.

(2) On page 1, strike lines 9 through 11 and substitute "from directly or indirectly owning an interest in the motor vehicle dealer if the".

Amendment No. 1 was withdrawn.

### **CSHB 733 - STATEMENT OF LEGISLATIVE INTENT**

REPRESENTATIVE HILL: Mr. Driver, you are aware that I chaired the study commission that looked at this issue?

REPRESENTATIVE DRIVER: Yes, sir, I certainly am.

HILL: And you are aware that of these three manufacturers, International is the only one that is American-owned?

DRIVER: International is in my district and it is American-owned. Yes, sir.

HILL: Are you aware that of these three manufacturers, International is the only one with a substantial capital investment in this state, and operating a manufacturing facility in Garland and employs close to 1,000 people?

DRIVER: Yes, sir. I believe the figure I was told was that they have a capital investment in Texas of \$140 million, and that last year the Garland plant alone produced trucks worth over \$2 billion.

HILL: Who were the stakeholders who agreed to this compromise bill?

DRIVER: It's my understanding the agreement was between two manufacturers that did not comply with TxDOT's interpretation of the 1999 law and have stayed in business. Texas department, I'm sorry, TADA and a coalition of heavy truck dealers. It's also my understanding, International, the one in my district, was part of a deal originally, but was carved out because TADA did not agree to anything that allowed them to reopen their stores.

HILL: Why does TADA even care about this bill?

DRIVER: That's a good question, Mr. Hill. This is really a heavy truck issue, it's not an automobile issue at all. In fact, this is a fight about heavy truck dealers and their ability to compete for heavy fleet sales. These used truck stores basically allow manufacturers to buy trade-ins from their dealers so the dealers can compete for fleet sales without being overly burdened with too many trade-ins.

HILL: So how does this affect International?

DRIVER: International would be the one in my district. Basically, International is trying to compete with these other heavy truck manufacturers that are able to support their dealers on fleet issues by having used truck centers. Yet the State of Texas tells International they can't do exactly the same thing. International dealers are at a substantial competitive disadvantage because of this.

HILL: It's been my understanding that this compromise bill is a deal that was cut, and that if any changes are made, the whole deal dies. And if the bill dies, we're putting more people out of business. Are you aware of who would benefit if the bill dies?

DRIVER: Well, I assume it's TADA and also a particular heavy truck dealer that is the only publicly-owned truck dealer in the country. He wants this bill dead because he's the only guy big enough to handle truck volume dealer trade-ins because of the cuts of the heavy dealer network. This dealer had sales last year of almost \$3 billion. He's a big player. He'd be virtually the only player if this bill doesn't pass.

HILL: So basically allowing these manufacturers to continue selling used trucks actually promotes competition rather than weakens it?

DRIVER: That's exactly right, sir.

HILL: Are you aware that the other manufacturers testified in the Transportation Committee that they would not oppose allowing International to be included in this agreement?

DRIVER: That's right. I don't see the difference in letting these guys have one store that would help these manufacturers compete with the other manufacturers, and one mega-heavy truck dealer.
