

INTERGOVERNMENTAL RELATIONS

Minutes - May 8, 1973

The Committee on Intergovernmental Relations met in the Lt. Governor's Committee Room at 9:00 A.M., Tuesday, May 8, 1973. The meeting was called to order by Chairman Jim Wallace. The Roll Call found Senators Wallace, Traeger, Adams, Herring and Patman present.

There being a quorum present, the Chair laid out Senate Bill 623, and recognized Senator Patman, sponsor of the bill. There were no witnesses. At the request of the sponsor, because of lack of quorum at the present time, the bill was to remain in Committee, in a "pending" status, until later.

The Chair laid out Senate Concurrent Resolution 90, and recognized Senator Schwartz, sponsor of the resolution. There were no witnesses. Senator Adams moved that Senate Concurrent Resolution 90 be reported back to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, Senate Concurrent Resolution 90 was returned to the Senate.

The Chair laid out Senate Bill 915, and recognized Senator Schwartz, sponsor of the bill. There were no witnesses. Senator Adams moved that Senate Bill 915 be returned to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, the bill was reported back to the Senate.

The Chair laid out Senate Bill 942, and recognized Senator Schwartz, sponsor of the bill. Land Commissioner Bob Armstrong appeared as a witness "in favor" of the bill. Senator Adams

sent up a Committee Substitute for Senate Bill 942. Senator Adams moved that Senate Bill 942 not be returned to the Senate, but Committee Substitute 942 be returned to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, Committee Substitute 942 was reported back to the Senate.

The Chair laid out Senate Bill 914, and recognized Senator Blanchard, sponsor of the bill. There was no action taken on Senate Bill 914.

The Chair laid out House Bill 1158, and recognized Senator Blanchard, Senate sponsor of the bill. Senator Herring sent up Committee Amendment #1 for adoption. It was adopted. Senator Adams moved that House Bill 1158, as amended, be reported back to the Senate with the recommendation that it do pass and be printed. With a majority of the Committee voting in the affirmative, House Bill 1158, as amended, was returned to the Senate.

The Chair laid out Senate Bill 381, and recognized Senator Adams, sponsor of the bill. There were no witnesses. Senator Adams moved that Senate Bill 381 be returned to the Senate with the recommendation that it do pass and be printed. The majority of the Committee voted in the affirmative. Senate Bill 381 was reported back to the Senate.

The Chair laid out Senate Bill 962, and recognized Senator Longoria, sponsor of the bill. There were no witnesses. Senator Adams moved that Senate Bill 962 be returned to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, Senate Bill 962 was reported back to the Senate.

The Chair laid out House Bill 1107, and recognized Senator Traeger, Senate sponsor of the bill. At the request of the Senate sponsor, the bill was tabled.

The Chair laid out House Bill 1135, and recognized Senator Wolff, Senate sponsor of the bill. There were no witnesses. Senator McKinnon sent up two amendments to the House Bill. The amendments were adopted. Senator Traeger moved that House Bill 1135, as amended, be reported out favorably. The majority of the Committee voting in the affirmative, House Bill 1135, as amended, was returned to the Senate with the recommendation that it do pass and be printed.

The Chair laid out House Bill 1231, and recognized Senator Brooks, Senate sponsor of the bill. There were no witnesses. Senator Adams moved that House Bill 1231 be reported out of Committee favorably. The majority of the Committee voting in the affirmative, House Bill 1231 was returned to the Senate with the recommendation that it do pass and be printed.

The Chair laid out House Bill 1232, and recognized Senator Brooks, Senate sponsor of the bill. There were no witnesses. Senator Herring moved that House Bill 1232 be reported out of Committee favorably. The majority of the Committee voting in the affirmative, House Bill 1232 was returned to the Senate with the recommendation that it do pass and be printed.

The Chair laid out House Bill 1481, and recognized Representative Anthony Hall, in lieu of Senator Gammage, Senate sponsor of the bill. Representative Hall was questioned by Senator Wallace. The Chair sent up Committee Substitute for House Bill 1481. Senator Traeger moved that House Bill 1481

do not pass, but the Committee Substitute in lieu thereof, do pass and be printed. The majority of the Committee voting in the affirmative, Committee Substitute 1481 was reported back to the Senate.

The Chair laid out House Bill 1558, and recognized Representative Hall. There were no witnesses. Senator Traeger moved that House Bill 1558 be reported back to the Senate with the recommendation that it do pass and be printed. The majority of the Committee voted in the affirmative. House Bill 1558 was returned to the Senate.

The Vice-Chairman laid out House Bill 809, and recognized Senator Wallace, Senate sponsor of the bill. There were no witnesses. Senator Adams moved that House Bill 809 be returned to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, House Bill 809 was reported back to the Senate.

The Chair laid out House Bill 1638, and recognized Senator Aikin, Senate sponsor of the bill. There were no witnesses. Senator Herring moved that House bill 1638 be reported back to the Senate with the recommendation that it do pass and be printed. With the majority of the Committee voting in the affirmative, House Bill 1638 was returned to the Senate.

There being no further business, the meeting recessed.
