The meeting was called to order by the Chairman. Although a quorum was not present, the Chairman stated testimony would be heard as permitted under the rules of the Committee.

The Chair laid out S.B. 1281 and recognized the sponsor, Senator Doggett. Lewis P. Reade, representing Big Brothers of America, appeared to speak on behalf of the bill. Upon conclusion of his testimony further action was postponed until May 2, 1977.

The Chair next laid out S.B. 260 and recognized Senator Clower. Wendall A. Odom, Jr., representing Consumer Fraud of D.A., testified for the bill. Further action was postponed until May 2, 1977.
