

Speaker's Committee Room

Public notice having been posted on H.B. No. 1445, H.B. No. 1039, H.B. No. 1331, H.B. No. 530, and H.B. No. 1533 at 11:30 a.m., March 30, 1973, the Committee on Liquor Regulation convened in a public hearing and was called to order by the Chairman, Mr. Lombardino, at 10:40 a.m.

Accordingly, the Chair appointed the following Subcommittee:


