Pursuant to an announcement on the House floor, in accordance with the House Rules, the House Redistricting Committee met in a formal meeting and was called to order by the Chair, Representative Tom Uher, at 4:32PM.

The roll was answered as follows:

A quorum was present.

The Chair laid out S.B. 1 (S560), H.B. 12 (H131S502) and S.B. 2.

The Chair laid out S.B. 1 and as its sponsor, explained the bill.

The Chair laid out Amendment #1 (H131S502) by Wilson regarding Harris County and asked Representative Wilson to explain the amendment.

Representative Earley now present.

Representative Grusendorf now present.

Representative Martinez moved adoption of the Wilson amendment.

The motion failed by the following vote:

The Chair laid out Amendment #1 by Wilson and asked Representative Wilson to explain the amendment.

Representative Rodriguez moved adoption of the Wilson amendment.

The motion failed by the following vote:

NAY: Earley, Finnell, Grusendorf, Russell, Seidlits (5).

PNV: Uher (1).

ABSENT: Blair, Craddick, Marchant, McCollough, Moreno (5).

Representative Finnell moved that S.B. 2 be reported favorably to the full House with the recommendation that it do pass.

The motion prevailed by the following vote:

AYE: Uher, Earley, Finnell, Martinez, Rodriguez, Russell, Seidlits, Wilson (8).

NAY: Jones, Grusendorf (2).

PNV: (0).

ABSENT: Blair, Craddick, Marchant, McCollough, Moreno (5).

The Chair laid out H.B. 23 by Jones and asked Representative Jones to explain the bill.

Representative Grusendorf moved adoption of the bill.

The motion failed by the following vote:
