



- The Defendants will provide to all opposing counsel before her testimony any papers Dr. Dawn-Fisher ultimately provides to the Court. The date upon which the Defendants provide the papers to opposing counsel will depend upon the date ultimately set for her preliminary testimony. Should the Plaintiffs or Intervenors desire to depose Dr. Dawn-Fisher before to the presentation of her testimony, the Defendants will accommodate that request.
- The Defendants reserve the right to call Dr. Dawn-Fisher as a rebuttal witness regarding any challenges made to her pre-trial testimony in the Plaintiffs' case in chief during the main trial. The State further reserves the right call Dr. Dawn-Fisher to testify in any capacity on other issues beyond those contained in her pre-trial testimony during the State's case-in-chief.
