SENATE BILL 1145 REREFERRED

On motion of Senator West and by unanimous consent, S.B. 1145 was withdrawn from the Committee on Health and Human Services and was rereferred to the Committee on Economic Development.

SENATE BILL 68 WITH HOUSE AMENDMENTS

Senator West called S.B. 68 from the President's table for consideration of the House amendments to the bill.

The President laid the bill and the House amendments before the Senate.

Amendment

Amend S.B. 68 by substituting in lieu thereof the following:

A BILL TO BE ENTITLED AN ACT

relating to the reckless discharge of a firearm; creating an offense and providing criminal penalties and civil remedies.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Chapter 42, Penal Code, is amended by adding Section 42.12 to read as follows:

Sec. 42.12. DISCHARGE OF FIREARM IN CERTAIN METROPOLITAN AREAS. (a) A person commits an offense if the person recklessly discharges a firearm inside the corporate limits of a municipality having a population of 100,000 or more.

(b) An offense under this section is a Class A misdemeanor.

(c) If conduct constituting an offense under this section also constitutes an offense under another section of this code, the person may be prosecuted under either section.

(d) Subsection (a) does not affect the authority of a municipality to enact an ordinance that prohibits the discharge of a firearm.

SECTION 2. Section 125.001, Civil Practice and Remedies Code, as amended by Section 1, Chapter 968, and Section 2, Chapter 857, Acts of the 73rd Legislature, Regular Session, 1993, is amended to read as follows:

Sec. 125.001. COMMON NUISANCE. A person who knowingly maintains a place to which persons habitually go for the purpose of prostitution or gambling in violation of the Penal Code, for the purpose

of discharge of a firearm in a public place in violation of Section 42.01(a)(9), Penal Code, for the purpose of reckless discharge of a firearm as described by Section 42.12 [42-015], Penal Code, for the purpose of engaging in organized criminal activity as a member of a combination [or as a member of a criminal street gang] as described by Section 71.02, Penal Code, or for the delivery or use of a controlled substance in violation of Chapter 481, Health and Safety Code, maintains a common nuisance.

SECTION 3. Section 125.004(a), Civil Practice and Remedies Code, is amended to read as follows:

(a) Proof that prostitution or gambling in violation of the Penal Code, that discharge of a firearm in a public place in violation of Section 42.01(a)(9), Penal Code, that reckless discharge of a firearm as described by Section 42.12 [42-015], Penal Code, or that the delivery or use of a controlled substance in violation of Chapter 481, Health and Safety Code, is frequently committed at the place involved or that the place is frequently used for reckless discharge of a firearm as described by Section 42.12 [42-015], Penal Code, is prima facie evidence that the proprietor knowingly permitted the act.

SECTION 4. Section 125.004(b), Civil Practice and Remedies Code, as amended by Section 3, Chapter 857, and Section 2, Chapter 968, Acts of the 73rd Legislature, Regular Session, 1993, is amended to read as follows:

(b) Evidence that persons have been convicted of gambling, committing prostitution, discharge of a firearm in a public place in violation of Section 42.01(a)(9), Penal Code, reckless discharge of a firearm as described by Section 42.12 [42-015], Penal Code, engaging in organized criminal activity as a member of a combination [~~or a criminal street gang~~] as described by Section 71.02, Penal Code, or delivering or using a controlled substance in violation of Chapter 481, Health and Safety Code, in the place involved is admissible to show knowledge on the part of the defendant that the act occurred. The originals or certified copies of the papers and judgments of those convictions are admissible in the suit for injunction, and oral evidence is admissible to show that the offense for which a person was convicted was committed at the place involved.

SECTION 5. Section 125.021, Civil Practice and Remedies Code, as amended by Section 1, Chapter 968, and Section 2, Chapter 857, Acts of the 73rd Legislature, Regular Session, 1993, is amended to read as follows:

Sec. 125.021. PUBLIC NUISANCE. The habitual use or the threatened or contemplated habitual use of any place for any of the following purposes is a public nuisance:

- (1) gambling, gambling promotion, or communicating gambling information prohibited by law;
- (2) promotion or aggravated promotion of prostitution;
- (3) compelling prostitution;
- (4) commercial manufacture, commercial distribution, or commercial exhibition of obscene material;

(5) commercial exhibition of live dances or other acts depicting real or simulated sexual intercourse or deviate sexual intercourse;

(6) engaging in a voluntary fight between a man and a bull if the fight is for a thing of value or a championship, if a thing of value is wagered on the fight, or if an admission fee for the fight is directly or indirectly charged, as prohibited by law;

(7) discharge of a firearm in a public place in violation of Section 42.01(a)(9), Penal Code;

(8) reckless discharge of a firearm as described by Section 42.12 [~~42.015~~], Penal Code; [or]

(9) [(7)] engaging in organized criminal activity as a member of a combination [~~or as a member of a criminal street gang~~] as described by Section 71.02, Penal Code; or

(10) [(8)] delivering or using a controlled substance in violation of Chapter 481, Health and Safety Code.

SECTION 6. Section 125.041, Civil Practice and Remedies Code, as amended by Section 1, Chapter 968, and Section 2, Chapter 857, Acts of the 73rd Legislature, Regular Session, 1993, is amended to read as follows:

Sec. 125.041. PUBLIC NUISANCE. For the purposes of this subchapter, a public nuisance is considered to exist at a place if one or more of the following acts occurs at that place on a regular basis:

(1) gambling, gambling promotion, or communication of gambling information, as prohibited by Chapter 47, Penal Code;

(2) promotion or aggravated promotion of prostitution, as prohibited by Chapter 43, Penal Code;

(3) compelling prostitution, as prohibited by Chapter 43, Penal Code;

(4) commercial manufacture, commercial distribution, or commercial exhibition of material that is obscene, as defined by Section 43.21, Penal Code;

(5) commercial exhibition of a live dance or other act in which a person engages in real or simulated sexual intercourse or deviate sexual intercourse, as defined by Section 43.01, Penal Code;

(6) discharge of a firearm in violation of Section 42.01(a)(9), Penal Code;

(7) reckless discharge of a firearm as described by Section 42.12 [~~42.015~~], Penal Code; [or]

(8) [(6)] engaging in organized criminal activity as a member of a combination [~~or as a member of a criminal street gang~~] as described by Section 71.02, Penal Code; or

(9) [(7)] manufacture, delivery, or use of a controlled substance in violation of Chapter 481, Health and Safety Code.

SECTION 7. The change in law made by Sections 2-6 of this Act applies only to a cause of action that accrues on or after the effective date of this Act. A cause of action that accrues before the effective date of this Act is governed by the law in effect at the time the cause of action accrued, and that law is continued in effect for that purpose.

SECTION 8. This Act takes effect September 1, 1995.

SECTION 9. The importance of this legislation and the crowded condition of the calendars in both houses create an emergency and an imperative public necessity that the constitutional rule requiring bills to be read on three several days in each house be suspended, and this rule is hereby suspended.

Floor Amendment No. 1

Amend C.S.S.B. 68, 1st committee printing, as follows:

(1) On page 5, between lines 17 and 18, insert the following:

SECTION 7. Subchapter C, Chapter 125, Civil Practice and Remedies Code, is amended by adding Section 125.046 to read as follows:

Sec. 125.046. ADDITIONAL REMEDIES; RECEIVER. (a) If, in any judicial proceeding under Subchapter A or B, a court determines that a person is maintaining a multiunit residential property that is a common nuisance or a multiunit residential property at which a public nuisance exists, the court may, on its own motion or on the motion of any party, order the appointment of a receiver to manage the property or render any other order allowed by law as necessary to abate the nuisance.

(b) A receiver appointed under this section may not be appointed for a period longer than one year.

(c) The court shall determine the management duties of the receiver, the amount to be paid the receiver, the method of payment, and the payment periods.

(d) A receiver appointed under this section shall continue to manage the property during the pendency of any appeal relating to the nuisance or the appointment of the receiver.

(e) In this section, "multiunit residential property" means improved real property with at least three dwelling units, including an apartment building or condominium. The term does not include:

(1) a property in which each dwelling unit is occupied by the owner of the property; or

(2) a single-family home or duplex.

(2) On page 5, strike line 18, and substitute "SECTION 8. The change in law made by Sections 2-7 of this".

(3) On page 5, line 24, strike "SECTION 8" and substitute "SECTION 9".

(4) On page 5, line 25, strike "SECTION 9" and substitute "SECTION 10".

Floor Amendment No. 2

Amend C.S.S.B. 68 by adding the following new section and renumbering the subsequent sections accordingly.

SECTION 1. Sections 22.05(b) and (e), Penal Code, are amended to read as follows:

(b) A person commits an offense if he knowingly discharges a firearm at or in the direction of:

- (1) one or more individuals; ~~[or]~~
 (2) a ~~[habitat,]~~ building[;] or vehicle and is reckless as to whether the ~~[habitation,]~~ building[;] or vehicle is occupied; or
 (3) a habitation.

(e) An offense under Subsection (a) is a class A misdemeanor. An offense under Subsection (b) is a felony of the second ~~[third]~~ degree.

Floor Amendment No. 1 on Third Reading

Amend C.S.S.B. 68 on third reading by amending 2nd reading Amendment No. 2 by Puente to read as follows:

Amend C.S.S.B. 68 by adding the following new section and renumbering the subsequent sections accordingly.

SECTION 1. Section 22.05(b), Penal Code, is amended to read as follows:

(b) A person commits an offense if he knowingly discharges a firearm at or in the direction of:

- (1) one or more individuals;
 (2) a habitation; or
 (3) a building, or vehicle and is reckless as to whether the building or vehicle is occupied. ~~[or (2) a habitation, building, or vehicle and is reckless as to whether the habitation, building, or vehicle is occupied.]~~

The amendments were read.

Senator West moved that the Senate do not concur in the House amendments, but that a conference committee be appointed to adjust the differences between the two Houses on the bill.

The motion prevailed.

HOUSE BILL 840 ON SECOND READING

On motion of Senator Brown and by unanimous consent, the regular order of business was suspended to take up for consideration at this time on its second reading and passage to third reading:

H.B. 840, Relating to the enforcement of the limitation on the amount that certain municipalities may retain from amounts collected for traffic violations.

The bill was read second time.

Senator Brown offered the following committee amendment to the bill:

Committee Amendment No. 1

Amend **H.B. 840** as follows:

(1) In SECTION 1, Section 144, subsection (f), insert the following language between the words "amounts" and "under":
"of 20 percent or more"

(2) In SECTION 1, Section 144, Subsection (f), delete the words "state treasurer" and substitute the words "state comptroller".

(3) In SECTION 1, Section 144, Subsection (g), delete the word "treasurer" and substitute the word "comptroller".

(4) Add a new SECTION 2 to read as follows:

"SECTION 2. Section 144, Uniform Act Regulating Traffic on Highways (Article 6701d, Vernon's Texas Civil Statutes), is amended by adding Subsection (h) to read as follows:

"(h) If the state comptroller conducts an audit pursuant to subsection (g) and it is determined that the city is retaining more than 20% of the amounts under subsection (b) and has not complied with subsection (f), the city shall pay for the costs incurred by the state comptroller to conduct the audit.

(5) Renumber existing SECTION 2 to be SECTION 3.
