A BILL TO BE ENTITLED

AN ACT

2 relating to the sale of alcoholic beverages to customers of a
3 package store during certain hours.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Chapter 22, Alcoholic Beverage Code, is amended
6 by adding Section 22.17 to read as follows:

7 Sec. 22.17. SALE TO CUSTOMER IN STORE AT CLOSING.
8 Notwithstanding any other provision of this code, if a customer has
9 entered a package store during hours in which the package store may
10 sell alcohol and is still in the store at the time the hours of legal
11 sale end, the permittee may allow the customer to remain in the
12 store for a reasonable amount of time to finish shopping, and the
13 permittee may sell an alcoholic beverage to that customer even
14 though the sale occurs after the designated end of the hours of
15 legal sale.

16 SECTION 2. This Act takes effect immediately if it receives
17 a vote of two-thirds of all the members elected to each house, as
18 provided by Section 39, Article III, Texas Constitution. If this
19 Act does not receive the vote necessary for immediate effect, this
20 Act takes effect September 1, 2015.

IN RE: HB824 by Kuempel (Relating to the sale of alcoholic beverages to customers of a package store during certain hours.), **Conference Committee Report**

No significant fiscal implication to the State is anticipated.

The bill would amend the Alcoholic Beverage Code relating to the sale of alcoholic beverages to customers of a package store after the designated end of the hours of legal sale. The Texas Alcoholic Beverage Commission has determined that the bill would not result in a significant fiscal impact to the State.

The bill would take effect immediately, or, if the bill does not receive the necessary vote, September 1, 2015.

Local Government Impact

No significant fiscal implication to units of local government is anticipated.



**Certification of Compliance with
