# LOCAL, CONSENT, AND RESOLUTIONS CALENDAR SECOND READING

The following bills were laid before the house, read second time, and passed to third reading, and the following resolutions were laid before the house on committee report and adopted (members registering votes are shown following the caption):

**HB 167** (by Raymond, Homer, Swinford, Chisum, and R. Cook), A bill to be entitled An Act relating to exempting a religious bible from attachment, execution, or other seizure for the satisfaction of debts.

**HB 178** (by Bailey), A bill to be entitled An Act relating to the issuance and renewal of certain licenses for junkyards and automotive wrecking and salvage yards.

#### Amendment No. 1

Representative Bailey offered the following amendment to HB 178:

Amend **HB 178** on page 1, line 16, by striking "<u>\$1,000</u>" and substituting "\$500".

Amendment No. 1 was adopted.

**CSHB 246** (by Alonzo), A bill to be entitled An Act relating to reports on cases of acquired immune deficiency syndrome and human immunodeficiency virus infection.

**HB 313** (by Pickett), A bill to be entitled An Act relating to an exemption from registration in this state for certain foreign commercial motor vehicles.

**CSHB 342** (by Naishtat), A bill to be entitled An Act relating to concurrent guardianship proceedings in this state and in a foreign jurisdiction.

**HB 365** (by Chisum), A bill to be entitled An Act relating to the exemption from regulation of certain charitable, religious, or civic organizations engaged in auction activities.

#### Amendment No. 1

Representative Chisum offered the following amendment to HB 365:

Amend **HB 365** on page 1, line 18, by striking "<u>conducting</u>" and substituting "organizing, arranging, or conducting".

Amendment No. 1 was adopted.

**CSHB 374** (by Pickett and Swinford), A bill to be entitled An Act relating to use of state buildings and grounds by a television or film production company.

**CSHB 398** (by B. Cook), A bill to be entitled An Act relating to designating a county official to file certain financial information with the county commissioners court.

**CSHB 402** (by Hill), A bill to be entitled An Act relating to a criminal violation of the open meetings law committed by a member of an appraisal district board of directors and to a prohibition on certain communications between a member of the board of directors and the chief appraiser of the district; providing penalties.

**CSHB 412** (by Eissler and Strama), A bill to be entitled An Act relating to erecting or maintaining certain outdoor signs or advertising; creating an offense; providing penalties.

**HB 482** (by Villarreal), A bill to be entitled An Act relating to the eligibility of certain educationally disadvantaged students to attend free prekindergarten classes.

**HB 504** (by Naishtat), A bill to be entitled An Act relating to payment for the provision of services by a metropolitan rapid transit authority to persons with disabilities in a unit of election that has withdrawn from the authority.

**CSHB 536** (by Truitt), A bill to be entitled An Act relating to the consent required for a municipality to annex a water or sewer district.

HB 591 was withdrawn.

**CSHB 860** (by Paxton and B. Cook), A bill to be entitled An Act relating to management, investment, and expenditure of institutional funds and adoption of the Uniform Prudent Management of Institutional Funds Act.

**SB 190** (Patrick - House Sponsor), in lieu of **HB 1008**, A bill to be entitled An Act relating to sales and use tax information provided by the comptroller of public accounts to certain municipalities.

Representative Patrick moved to lay HB 1008 on the table subject to call.

The motion prevailed.

**CSHB 1029** (by Goolsby), A bill to be entitled An Act relating to an exemption from electrician licensing requirements for certain work performed by a plumber.

**CSHB 1032** (by Puente), A bill to be entitled An Act relating to amendments to regional water plans. (Phillips recorded voting no.)

HB 1126 was withdrawn.

**CSHB 1210** (by Jackson), A bill to be entitled An Act relating to the extension of the deadline for filing an application for a refund of an overpayment or erroneous payment of ad valorem taxes.

**HB 1298** (by Heflin), A bill to be entitled An Act relating to the terms and election of the members of the board of directors of the Stonewall County Hospital District.

HB 1331 was withdrawn.

**HB 1388** (by Naishtat), A bill to be entitled An Act relating to the duty of the judge of the 147th District Court to impanel grand juries and to the terms of court for certain district courts in Travis County.

**HB 1396** (by Dukes and Coleman), A bill to be entitled An Act relating to the Office for the Elimination of Health Disparities and the health disparities task force. (Phillips and Talton recorded voting no.)

**CSHB 1397** (by C. Howard and Rodriguez), A bill to be entitled An Act relating to the inclusion in a notice of appraised value of information regarding ad valorem tax exemptions.

**HB 1521** (by Kolkhorst), A bill to be entitled An Act relating to the prohibition of signs on certain roads.

#### Amendment No. 1 (Committee Amendment No. 1)

Representative Haggerty offered the following committee amendment to **HB 1521**:

Amend **HB 1521** by striking Section 2 (effective date provisions) and substituting the following:

SECTION 2. APPLICABILITY. A landowner to whom a notice is mailed by the county clerk as provided by Section 3(b) of this Act may exclude the landowner's property from the application of Section 1 of this Act by notifying the Texas Department of Transportation in writing, by certified mail. In order for the landowner's property to be excluded from the application of Section 1 of this Act, the landowner's notice must be received by the Texas Department of Transportation within one year of the date the Texas Department of Transportation receives notification from all appropriate county clerks that notices were mailed to landowners as provided in Section 3(b) of this Act. The exclusion of the landowner from the application of Section 1 of this Act becomes effective on the date the landowner's notice is received by the Texas Department of Transportation.

SECTION 3. EFFECTIVE DATE. (a) Except as otherwise provided by this section, this Act takes effect on September 1, 2007.

(b) Before Section 1 of this Act can become effective, the county clerk of the county or counties in which a segment of public road affected by this Act is located must send a written notice, by certified mail, to each landowner who owns real property, according to the most recent certified tax appraisal roll, along a segment of public road affected by this Act. The notice shall also be published in a newspaper of general circulation in the county or counties in which a segment of public road affected by this Act is located. The notice shall identify the segment of public road affected by this Act and state that the landowner's future right to lease the landowner's property for the purpose of erecting an off-premise sign will be terminated unless the landowner notifies the Texas Department of Transportation that the landowner plans to exclude the landowner's property from the application of the Act. The notice must be sent to landowners and published by the appropriate county clerk or clerks in accordance with this subsection within 45 days of the effective date of this Act. The

appropriate county clerk or clerks shall notify the Texas Department of Transportation in writing, by certified mail, when the notice is mailed to the landowners and published in accordance with this subsection. The notice provided to the Texas Department of Transportation by a county clerk is public information for the purposes of Chapter 552, Government Code, and must include the following information:

(1) the affidavit of the publisher of the newspaper notice indicating the date the notice was published, accompanied by a printed copy of the notice as published; and

(2) the affidavit of the county clerk certifying the date notice was mailed to the landowners, accompanied by a copy of the notice and a list of the landowners to whom the notice was mailed.

(c) Section 1 of this Act takes effect on the 91st day after the Texas Department of Transportation receives notification from all appropriate county clerks as provided in Subsection (b).

Amendment No. 1 was adopted.
