CANVASSING THE VOTES CAST FOR GOVERNOR AND LIEUTENANT GOVERNOR

(The House of Representatives and Senate in Joint Session)

In accordance with the provisions of **SCR 3** providing for a joint session of the house and senate for the purpose of counting the votes for the governor of Texas and the lieutenant governor of Texas cast at the general election, held on November 6, 2018, the honorable senators, at 11:59 a.m., were admitted to the hall of the house and occupied seats arranged for them.

President Pro Tempore Kirk Watson was escorted to the speaker's rostrum and called the senate to order.

Speaker Bonnen called the house of representatives to order at 12:12 p.m.

A quorum of the house was announced present.

A quorum of the senate was announced present.

Speaker Bonnen stated that the house and senate were in joint session pursuant to SCR 3 for the purpose of counting the votes for governor of Texas and lieutenant governor of Texas cast at the last general election, held on November 6, 2018.

JOINT COMMITTEE APPOINTED

Speaker Bonnen delivered the official returns of the election to the secretary of state.
