But the best party that I have ever had with them is when we were at a party and we'd start looking at each other, and we were like "we're bored; we need to go someplace else," and we'd end up at a local watering hole together, telling stories and talking about politics and life. You never think about when you see somebody the last time if that's the last time that you're going to see them. We got a chance to see him right around Christmas. And it was just a shock that we lost him. But I have in my memory, like all of us do when we lose our friends, those long-lasting memories of our friendship. And today we wish you, Alice, our most sincere sympathy, and we'll always remember Glen in our hearts.
