BACKGROUND: Education Code, ch. 37, subch. D governs the discipline and penalties

associated with the protection of school buildings and grounds.

Sec. 37.102 authorizes a school district to adopt rules for the safety and welfare of students, employees, property, and other considerations deemed necessary to carry out the subchapter and the governance of the district. Laws or ordinances regulating traffic on a public highway or street apply to the operation of vehicles on school property. Sec. 37.102(c) states that a person found in violation under the subchapter or any rule adopted under the subchapter commits an offense. An offense under sec. 37.102 is a class

C misdemeanor (maximum fine of \$500).

School districts have made wide application of sec. 37.102 to punish infractions including tardiness and gum chewing, and some districts have prosecuted students for these infractions. Students who are found guilty receive a criminal record for breaking a school policy.

DIGEST: CSHB 278 would amend sec. 37.102(c) to limit the application of a

criminal penalty under subchapter D to the violation of rules providing for

the operation and parking of vehicles on school property.

The bill would take effect September 1, 2007.

NOTES: The original bill would have repealed Education Code, sec. 37.102(c).

A similar bill, SB 443 by Hinojosa, which passed the Senate by 31-0 on

May 1, would repeal Education Code, sec. 37.102(c).
