- BACKGROUND:** Education Code, ch. 134 establishes the Jobs and Education for Texans (JET) Grant Program to provide grants to defray the start-up costs associated with the development of new career and technical education programs at public junior colleges, public technical institutes, public state colleges, and independent school districts that meet certain requirements.
- DIGEST:** HB 618 would extend eligibility to participate in the Jobs and Education for Texans Grant Program to open-enrollment charter schools that had entered into a partnership with a public junior college, public technical institute, or public state college for the purpose of promoting career and

technical education or offering dual credit courses to the district's or school's students.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2021.

**SUPPORTERS
SAY:**

HB 618 would allow charter schools to apply for funding from the Jobs and Education for Texans (JET) Grant Program. This would align charter schools with school districts in their ability to seek grant funding to purchase equipment for use in career and technical education (CTE) classes.

One charter school in South Texas built a center for innovation to help high school students gain entry into high-demand careers after graduation but was deemed ineligible for a JET grant to purchase medical equipment for student learning. Allowing charter schools to increase CTE offerings that lead to a degree or certification in a high-demand occupation would help Texas meet its higher education goals.

**CRITICS
SAY:**

HB 618 could result in fewer grants going to district schools where the vast majority of Texas students are educated because JET grant applications already exceed available funding.
