BACKGROUND:

Concerns have been raised that certain statutes from the 1980s and 1990s still require certain educational materials to include language emphasizing that homosexual conduct is a criminal offense, which is still in effect.

DIGEST:

CSHB 2055 would repeal the offense of engaging in deviate sexual intercourse with another individual of the same sex, which is a class C misdemeanor (maximum fine of \$500).

The bill also would remove requirements for certain health education programs to include materials stating that homosexual conduct is a criminal offense.

The bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2023.
