**BACKGROUND:** 

Some have suggested that an interstate compact for border enforcement could help to address gaps in existing federal border policy and strengthen states' capabilities to address continuing security issues at the border.

DIGEST:

CSHB 82 would require the governor, on behalf of the state, to develop and execute an interstate compact for border security among interested states. The bill would specify that it was the intent of the Legislature that the compact not require congressional approval. The compact could not increase the political power of the compacting states in relation to the federal government.

The compact would be required to provide for joint action among compacting states on matters that included:

- sharing law enforcement intelligence on illegal activity occurring at the border with Mexico;
- sharing state resources in order to build a physical barrier, a
  comprehensive technological surveillance system, or both, on state
  land to deter or detect illegal activity occurring at the border with
  Mexico; and
- sharing other law enforcement resources to ensure the protection of

personnel and property.

This bill would take immediate effect if finally passed by a two-thirds record vote of the membership of each house. Otherwise, it would take effect September 1, 2023.
