- (a) To qualify for a license to practice pharmacy, an applicant for licensing by examination must submit to the board:
 - (1) a license fee set by the board; and
 - (2) a completed application on a form prescribed by the board with satisfactory sworn evidence that the applicant:
 - (A) is at least 18 years of age;
 - (B) is of good moral character;
- (C) has completed a minimum of a 1,000 hour internship or other program that has been approved by the board or has demonstrated, to the board's satisfaction, experience in the practice of pharmacy that meets or exceeds the board's minimum internship requirements;
- (D) has graduated and received a professional practice degree, as defined by board rule, from an accredited pharmacy degree program approved by the board;
- (E) has passed the examination required by the board; and
- (F) has not had a pharmacist license granted by another state restricted, suspended, revoked, or surrendered, for any reason—, unless such license was restricted, suspended, revoked, or surrendered because the applicant refused or will refuse to provide

patient counseling or to dispense, distribute, or administer a drug or device when doing so would violate the sincerely-held religious beliefs of the applicant.

- (b) Each applicant must obtain practical experience in the practice of pharmacy concurrent with college attendance or after college graduation, or both, under conditions the board determines.
- (c) For purposes of this Section, no sincerely-held religious belief or conduct shall be considered to be a deficiency in the applicant's moral character.

SECTION ____. Chapter 558.058, Occupations Code, is amended to read as follows:

Sec. 558.058. ACCESSIBILITY OF EXAMINATION. The board by rule shall ensure that:

- (a) an examination under this subchapter is administered to applicants with disabilities in compliance with the Americans with Disabilities Act of 1990 (42 U.S.C. Section 12101 et seq.) \div ; and
- (b) religious accommodations are provided to applicants with sincerely-held religious beliefs that limit the days on which an examination may be taken.

- (B) proof that the current license and any other license granted to the applicant by another state has not been restricted, suspended, revoked, or surrendered for any reason; and, unless such license was restricted, suspended, revoked, or surrendered because the applicant refused or will refuse to provide patient counseling or to dispense, distribute, or administer a drug or device when doing so would violate the sincerely-held religious beliefs of the applicant;
 - (5) pass the Texas Pharmacy Jurisprudence examination.
- (b) An applicant is not eligible for licensing by reciprocity unless the state in which the applicant is currently or was initially licensed as a pharmacist grants reciprocal licensing to pharmacists licensed by examination in this state, under like circumstances and conditions.
- (c) For purposes of this Section, no sincerely-held religious belief or conduct shall be considered to be a deficiency in the applicant's moral character.

SECTION ____. Chapter 559.003(e), Occupations Code, is amended to read as follows:

Sec. 559.003. REQUIREMENTS FOR RENEWAL.

(e) A person may not renew a license to practice pharmacy if the person holds a license to practice pharmacy in another state that has been suspended, revoked, canceled, or subject to an action that prohibits the person from practicing pharmacy in that state, unless such license was restricted, suspended, revoked, or surrendered because the applicant refused or will refuse to provide patient counseling or to dispense, distribute, or administer a drug or device when doing so would violate the sincerely-held religious beliefs of the applicant.

(iv) the pharmacist license number of the pharmacist-in-charge; and (v) any other information the board determines necessary. SECTION ____.
